Invoices will be sent to Parents/Carers on the Blossom Educational Parent App in advance.

All fees are due in advance and are expected to be received on the first working day of the month. Late payments will be subject to a late payment fee of £25 per week, plus interest on any outstanding balance(s).

Early Education Funding information:

15 & 30 Hours Early Education Funding from 9 months:

Eligible children (the term after they turn 9 months), in England are entitled to a maximum of 1140 hours per year per year. Children receive funding for up to 30 hours a week, for 38 weeks of the year. As Myton Green Children's Nursery and Pre-School is open all year round, we "stretch" the funded hours across the whole year. If you are claiming 570 hours, we "stretch" it to a maximum of 47.5 hours per calendar month or 11.176 hours per week for 51 weeks.

All Children, the term after their third birthday, are eligible for the 15 hours funding.

The Early Education Funding:

- Must be with an [approved childcare provider](#) (Myton Green meets this criteria)
- Stops when your child starts reception / 31st August. (or reaches compulsory school age, if later)

Extended 30 Hours Early Education Funding:

You may be able to apply for an additional 570 hours of Extended Early Education Funding on top of the Universal Funding, giving your child a maximum of 1140 hours per year. Again, as we are open all year round, we 'stretch' this funding across the year, giving a maximum of 95 hours per calendar month or 22.35 hours per week for 51 weeks.

Stretched funding:

At Myton Green, Early Education Funding (EEF) is stretched over 51 weeks a year and ***we do not offer funding on a term time only basis.***

Early Education Funding (EEF) within our sessions is 3.725 hours per session. A session is either a morning (09:15-13:00) or afternoon (13:00-16:45). **If your child attends for a full day (8am-6pm), this is classed as two sessions** – giving you a maximum of 7.45 hours of EEF per day. We are unable to adapt our funding structure and can only offer 3.725 hours of EEF or 7.45 hours of EEF per day.

To use your Early Education Funding entitlement with us, you must choose one of our packages below that best suits your needs.

Funding option A:

(For children aged 9 months+ in receipt of Early Education Funding)

Funding option A-

- We deliver the funded hours in blocks of 3.275 hours. Session times are as follows:
Morning Session: 9:15 AM - 1:00 PM
Afternoon Session: 1:00 PM - 4:45 PM
- Session times and days will be allocated 2 weeks before the start of each term. Specific days and times can be requested but are not guaranteed.
- Parents must reapply each term for their child's funded hours. Places are not guaranteed for those who reapply.
- Sessions are fixed for one term; however, the nursery reserves the right to change or reduce sessions to maintain legal ratios.
- No additional hours or days can be purchased on top of the government-funded hours when selecting option A.
- Free entitlement hours are strictly for EYFS provision and do not include any consumables, meals, or snacks.
- Access to enhanced provision is not provided within the funded hours in Option A. This includes the use of Blossom Educational.
- Parents may opt to purchase our snack and meal package at a charge of £6.00 per funded session, billed and payable monthly in advance. For a full day this is £6.00 x 2 = £12.00.
- A refundable registration fee of £100 is required to book your term's sessions. The fee will be refunded after we receive that term's interim government payment.
- Funded sessions are not 'swappable' when your child is absent or on holiday. They are set sessions each term and are not moveable under any circumstance.

FAQ's:

- **I want to reserve a Monday morning and a Tuesday afternoon, how does this work?**

Myton Green Children's Nursery cannot guarantee availability until two weeks before the new term when choosing Funding Option A. If you are granted the sessions you requested for one term, there is a possibility that they may not be available again in the following term. However, Funding Option B allows you to reserve specific days and sessions, providing reliability for you and your child.

- **I want to reserve a space for my baby, until they go to school. Is this possible?**

When selecting Funding Option A, we cannot guarantee that your child's space will be available each term. You will need to reapply for sessions every term, and they will be allocated based on availability and staffing levels. In contrast, Funding Option B allows you to reserve specific days and sessions until your child leaves for school, providing more stability.

- **I want my child to attend an extra session each week, outside of the funded hours in option A?**

When parents/carers have booked *funding option A*, the option to book additional sessions/services is unavailable. However, if you have selected *funding option B*, you will be able to request extra sessions outside of your usual contracted days.

Funding option B:

(For children aged 9 months+ in receipt of Early Education Funding)

Funding option B-

Funding option B is a package where you purchase additional hours to make up a full session(s). This gives parents/carers the option to book set days and sessions. Sessions in Funding option B are 08:00 – 13:00, 13:00 – 18:00 or 08:00 – 18:00.

Funding option B is fully inclusive of all meals/snacks, extra-curricular activities, online learning journals plus more and is most suited to families who need reliable, guaranteed childcare and early years education.

When choosing Funding option B:

- Session patterns are secured indefinitely, subject to initial session availability.
- Your place is fully inclusive of all extra-curricular activities and enhanced provision.
- You will be able to book full morning, afternoon or day sessions outside of your funded hours.
- Parents/Carers who have chosen funding option B will be able to request ad-hoc days and early bird sessions.
- Funding is stretched over 51 weeks
- You will have full access to the Blossom Educational parent app.

Package costings breakdown-

Half day = Blossom Educational £0.75 + Meals £6.00 + Extracurricular activities, seasonal baking, crafting etc £6.00 x 1.275 Hours unfunded care £17.25 = **£30.00 per Half day**

Full day = Blossom Educational £0.75 x 2 + Meals £6.00 x 2 + Extracurricular activities, seasonal baking, crafting etc £6.00 x 2 + 2.55 Hours unfunded care £19.50 (with full day discount on unfunded hours) = **£45.00 per full day**

FAQ's:

- **I want to reserve a Monday morning and a Tuesday afternoon, how does this work?**
Myton Green Children's Nursery and Pre-School will be able to confirm your set booking pattern when you have chosen option B. Once we have confirmed your space, the sessions you have requested will be guaranteed throughout your child's time at nursery.
- **I want to reserve a space for my baby, until they go to school. Is this possible?**
When choosing *funding option B*, we check availability and once confirmed, we guarantee the space will be available until your child leaves for school.
- **I want my child to attend an extra session each week, outside of the funded hours in option B?**
When parents/carers have chosen *funding option B*, the option to book additional sessions/services is available. Please contact the nursery office to get extra sessions booked in.
- **Will my child be able to access the extra-curricular activities?**
If you have selected *funding option B*, your child will be able to access the extra-curricular activities available during their session.

* With Funding Option B, once you have booked your chosen sessions and received confirmation from the nursery, there is no need to re-request them each term, as they are secured on a permanent basis. If you need to make changes to your booked sessions, we are happy to accommodate those changes, subject to availability, with a notice period of one month.

Funding option B package breakdown:

Early Education Funding (EEF) is delivered in increments of 3.725 hours per session.

EEF sessions are either a morning (09:15-13:00) or afternoon (13:00-16:45). When selecting funding option B you are purchasing the additional hours not included in the EEF session. This means you are booking *full* sessions. Our full sessions are as follows:

Morning (08:00-13:00) or **Afternoon** (13:00-18:00) or **Full day** (08:00-18:00)

What's included in the unfunded session charge?

The unfunded session charge covers the unfunded portions of the session and is fully inclusive of and is not limited to:

Food and Drinks- (Breakfast, Snacks, Lunch, Tea and Desserts.)

We offer a comprehensive eight-week menu featuring a wide range of delicious meals, all freshly prepared on-site by our dedicated cooks. Our focus is on nutrition and variety, and we proudly maintain a 5-star food hygiene rating. Our cooks are trained to accommodate all allergies, intolerances, and dietary preferences. We incorporate a variety of fruits, vegetables, and pulses into our sauces and prioritise wholewheat products whenever possible.

For desserts, you won't find cakes or processed sugary foods; instead, we serve fresh fruit, natural yogurts, and the occasional homemade pudding. At breakfast, we provide a selection of low-sugar cereals, fresh fruit, toast, and yogurt. We also support local businesses by having glass bottles of local dairy milk delivered.

Blossom Educational- (Observations, Reports, Daily Diary, Photos, etc.)

Blossom Educational is a versatile online learning platform that we use to share daily and termly information with parents. It serves as an excellent tool for enhancing communication between our setting and families at home. With Blossom, families can maintain a detailed digital diary, complete with photographs, that lasts a lifetime. This resource remains accessible for revisiting, even after your child has transitioned from our setting.

Extra-Curricular Activities- (Cool Sportz, French, Magical World of Stories, Creative Flair, etc.)

We partner with external providers to offer high-quality and engaging extra-curricular activities throughout the week. Currently, we provide sessions from Cool Sportz, the Magical World of Stories, French lessons, and Creative Flair music and dance. These activities enhance our EYFS provision and help to further support your child's development.

Seasonal Crafting, Celebratory Activities, Cultural Activities & Baking/Cooking--

As part of our enhanced provision, your child will have the opportunity to engage in a variety of additional activities that are not included in the EEF funding. These activities encompass seasonal crafting, celebratory events, cultural experiences, and baking or cooking sessions, providing enriching experiences beyond the standard curriculum.

Sessions that are partly funded are charged at the following rate:

½ day sessions = **£30.00**

Full day sessions = **£45.00*** *Full day sessions are given a discount of £15 per full day when two funding sessions are used together
